## Methodological note

This study is based on a representative sample of the population in ten Latin American countries (with an average representativeness of 87%). The surveys were conducted in Spanish and Portuguese.

#### Sample

12.000 surveys in 10 different countries of the region (Argentina, Bolivia, Brazil, Chile, Colombia, Costa Rica, Guatemala, Mexico, Uruguay and Venezuela).

#### Confidence level

95%, with an error margin of 3%.

#### **Target population**

Individuals of legal age with secondary education or higher, residents in Latin America.

#### Data collection

10th of September to 4th of October 2021.




















































